- Applicants who will be coming for document verification after receiving allotment for this college and after paying 5000/- seat acceptance fee, must carefully read WBJEEB information brochure 2024 and counselling notification 2024. Those guidelines will be followed.
- On reporting, physical verification of the required documents will be carried out. After successful verification of the documents the applicants' upgradation choice ("YES" or "NO") will be recorded.
- Presence of Applicants is a must.

Dates and time for document verification (at College Conference Room, Main Building, 1st floor):

1st Round: 23.07.2024, 24.07.2024, 25.07.2024, 26.07.2024, 27.07.2024 and 29.07.2024; from 11:00 am to 2:00 pm.

2nd Round: 31.07.2024, 01.08.2024, 02.08.2024 and 03.08.2024; from 11.00 am to 2.00 pm.

Mop-Up Round: 09.08.2024, 10.08.2024 and 12.08.2024; from 11.00 am to 2.00 pm.

Note: Dates may change as per notice of WBJEEB. (however timing will remain same as 11:00 am to 2:00 pm)

Documents Required for Verification: (original and one self-attested photocopy):

1. Allotment letter obtained from student's log in (for this college)
2. WBJEE 2024 rank card
3. Proof of date of Birth (10th admit / DoB certificate)
4. Mark sheet of 10th (Madhyamik or equivalent)
5. Mark sheet of 12th (Higher Secondary or equivalent)
6. Domicile certificate as per WBJEEB specified format (As per section 3.4, 3.4.1 and 3.4.2 of WBJEE 2024 information bulletin)
7. SC / ST / OBC – A / OBC - B / EWS / PWD Certificate (if applicable)
 - a. (As per section 5.1, 5.2, 5.3, 5.4 and 5.5 of WBJEE 2024 information bulletin).

- b. For OBC candidates, Category A or B must be written in certificate and NCL (Non Creamy Layer) certificate issued on and after 01.04.2024 is a must requirement for OBC – A or B; certificate issuing authority should be as per WBJEEB guidelines.
 - c. EWS candidates must bring certificate to be issued on and after 01.04.2024, certificate issuing authority should be as per WBJEEB guidelines.
8. **For TFW “Yes” candidates:** Income certificate as per WBJEEB specified format (As per section 6.1 and 6.2 of WBJEE 2024 information bulletin)
 9. AADHAR Card
 10. One passport size photo
 11. YES / NO upgradation form (to be downloaded from WBJEEB website)

Screen shots or photographs of the screen etc. are not acceptable as any valid document.
